Post Card Survey*	<p>Council Staff presented documentation of the number of unduplicated clients for each service category. The Committee discussed how to obtain the most possible responses per category. A motion was made by Kristina Kendricks-Clark with a second by Richard Benavidez to conduct the survey as follows:</p> <p>For categories with less than 50 clients to date, surveys will be created for all the unduplicated clients to date.
