	Dennis Poupart inquired if there are any life skill classes for newly diagnosed individuals. Currently, Sunburst Projects is offering these classes and are looking into offering DBT therapy. Danielle will reach out to other agencies to see if they are offering these.
Reflectiveness Update	Paula Gammell announced that HRSA requires changes to how the Council calculates reflectiveness going forward for the new Fiscal Year. For a member of the council to count for reflectiveness the member needs to be a Part A recipient. Previously reflectiveness was counted if a member was an unaffiliated consumer of HIV services in the TGA regardless of how their care was paid for. This can be problematic for the recruitment of new members as

	most people do not know how their care is being funded. There are a few members who are consumers but they do not receive Part A services, it is recommended that they utilize the services if possible. Currently, there are only a few open seats for Affected Community members and a few of them are specific such as Parole and Native American. There are also alternate seats that could be occupied. Richard Benavidez suggested that the Council updates its interview questions to better screen members and assess their commitment to the Council. With these new changes, the Council is at 30.4% reflectiveness but two new non-consumer seats will be filled next month causing reflectiveness to drop. ACC is hoping to recruit some new individuals at their community event on March 8 <sup>th</sup> .

#### National Native HIV/AIDS Awareness Day

March 20th, 2023, is National Native HIV/AIDS Awareness Day. According to HIV.gov "National Native HIV/AIDS Awareness Day was first observed in 2007. This day is observed on the first day of Spring each year. The 2023 observance is recognized on March 20th.

The theme for 2023 is "Weaving Our Horizon: Strength. CommUnity. Equity." The <u>National Native</u> <u>HIV Network</u> plans the observance each year. The observance is a national mobilization effort designed to encourage Native people (American Indians, Alaska Natives, and Native Hawaiians) across the United States and Territorial Areas to get educated, get tested, get involved in prevention, and get treated for HIV.

You can learn more about HISstory, HERstory, THEIRstory, OURstory: Storytelling as Resilience, an initiative aimed at increasing awareness and knowledge of HIV and breaking down the barriers of HIV/AIDS stigma in indigenous communities through the tradition of story telling <u>here</u>.

To support the development of comprehensive solutions to end the HIV epidemic in Indian Country, the Northwest Portland Area Indian Health Board, alongside the Indian Health Service National HIV Program, and other partners, created <u>The Indigenous</u> <u>HIV/AIDS Syndemic Strategy: Weaving Together the National HIV, STI, and Viral Hepatitis Plans</u>. This document contains emerging practices, existing initiatives, as well as traditional Indigenous knowledge that can be used by Tribal decision-makers to develop community-tailored interventions that address the syndemics of HIV, STIs, and viral hepatitis." #### National Youth HIV/AIDS Awareness Day

April 10th, 2023, is National Youth HIV & AIDS Awareness Day. <u>Advocates for Youth</u> and its partners direct this observance. According to Advocates for Youth "National Youth HIV & AIDS Awareness Day (NYHAAD), annually on April 10th, is a day to educate the public about the impact of HIV and AIDS on young people.

The day also highlights the HIV prevention, treatment, and care campaigns of young people in the U.S. Today's young people are the first generation who have never known a world without HIV and AIDS. The CDC reports that in 2018, youth aged 13 to 24 made up 21% of the 37,832 new HIV diagnoses in the United States (US) and dependent areas. Young people living with HIV are the least likely of any age group to be retained in care and have a suppressed viral load. Addressing the impact of HIV on young people requires they have access to affirming, culturally-competent, and medically accurate resources and tools.

The National Youth HIV & AIDS Awareness Day (NYHAAD) Collective is comprised of youth activists leading HIV prevention, treatment, and care campaigns in their communities. Their campaigns highlight the challenges faced by young people living with and impacted by HIV, offer insight on how they combat stigma and discrimination on local, state, and federal levels, and enhance the awareness among physicians, policymakers, and youth-serving organization staff, etc. about the existing disparities." 

### National Transgender HIV Testing Day

April 18th, 2023, is National Transgender HIV Testing Day. Transgender individuals face many barriers to healthcare access, including transphobia, anticipated HIV stigma, and racial discrimination, which may make them hesitant to seek care such as HIV testing and treatment (Centers for Disease Control and Prevention [CDC], 2022). A Special Report by the CDC, which surveyed 1,608 transgender women in seven major U.S. cities between 2019 and 2020, found that 42.2% were HIV positive (CDC, 2021). The report also found that 35% of participants were Black/African American, and 40% were Hispanic or Latina. Of the participants surveyed, 17% did not have health insurance, 42% had experienced homelessness within a year before the survey, and 63% had a household income at or below the federal poverty level. Evidenced-based multilevel interventions delivering individual counseling, peer navigation, and community mobilization that addresses structural, biomedical, and behavioral risk as well as focusing on the disparities above, can help overcome healthcare barriers for transgender individuals (Centers for Disease Control and Prevention, 2022). #### National Asian and Pacific Islander HIV/AIDS Awareness Day

May 19th, 2023, is National Asian & Pacific Islander HIV/AIDS Awareness Day. According to the National Institutes of Health it was "Founded by the Banyan Tree Project and the San Francisco Community Health Center on May 19, 2005, the National Asian & Pacific Islander HIV/AIDS Awareness Day raises awareness about the impact of HIV and AIDS-related stigma in Asian and Pacific Islander (API) communities.



Although the API communities are the fastest growing minority group, HIV diagnoses in this group have remained stable. According to the Centers for Disease Control and Prevention (CDC), in the U.S. and dependent territories, most new HIV diagnoses in API communities were among gay, bisexual, and other men who have sex with men. Other segments of the API population in the U.S. who experienced new HIV diagnoses were women and people who inject drugs. However, stigma is a primary barrier to HIV testing and access to services in

API Americans. Stigma related to HIV infection in API communities have created challenges regarding transmission, testing, and treatment. Intensified efforts are needed to support culturally tailored measures that meet the API communities' HIV prevention, treatment, and care needs." (HIVinfo.NIH.gov, 2023)
