Welcome, Introductions and Announcements	 A Welcome B Announcements: Sunburst Projects is accepting applications for the annual Camp Sunburst. It is being held June 30 – July 5 for youth ages 6 -17, who are either affected or infected. Sunburst Projects is hosting its annual One Love Conference for HIV+ young adults ages 18-26. The conference will be held July 14 – 27 at UC Davis. The Council's Affected Communities Committee (ACC) will be participating in the Mind, Body and Spirit event at Sacramento City College on April 20th. ACC has coordinated with Gilead to host the Evolution of HIV Treatment on May 18th at Mulvaney's beginning at 12 noon. The Planning Council is recruiting members, particularly people living with HIV as we are not meeting the Reflectiveness mandate. Susan Farrington informed that other TGA's are having similar recruitment problems. San Jose and the Inland Empire are both considering switching to a Planning Group rather than a Council as there are fewer mandates. HRSA Part A will be conducting its site visit this August 7 through 11, 2017. The Office of AIDS' Health Insurance Premium Program will assist with co-pays for ambulances. It will also cover emergency room expenses if the client is discharged the same day. It does not cover dental co-pays however.
