Presentation: David Bain NAMI (National Alliance on Mental Illness)	 David Bain provided an overview of services offered at NAMI. They offer support groups and 90 minutes long classes. Peer to Peer is a free eight session educational program for adults with mental health conditions who are looking to better understand themselves and their recovery. Family to Family Classes for 1 night a week for 8 weeks. This facility helps patients, in their own voice, understand their own mental illness. They offer a class called <i>Ending the Silence</i>. This is a presentation for Middle and High School students, School staff and families that helps audience members learn about the warning signs of mental health conditions and what steps to take if you or a loved one showing symptoms of mental illness. David Bain told a story about a homeless woman that has a history of mental illness. During that story, Dennis expressed interest in helping a woman who was a meth addict with mental illness and trying to get her connected to a new joint program between Hope Coop, WellSpace and Loaves and Fishes.

Fiscal Agent Reports November 2020 Monthly Fiscal Report*	The November 2020 Monthly Fiscal Report was presented for review and approval. Expenditures should be at approximately 75% however, all counties are underspending due to the COVID-19 pandemic. Motion to approve the November Monthly report as presented was made by Susan Farrington with a second by Richard Benavidez and approved by consensus.
FY20 Third Quarter Fiscal Agent Report	The Fiscal Agent submitted the anticipated carryover at the full 5%. The TGA received noticed that HRSA is considering programmatic penalty waivers and are hopeful this will include a waiver of the limitation of the 5% carryover as we anticipate a higher carryover balance.
	The Fiscal Agent referred participants to the Executive Summary for a brief overview of the program as of the third quarter of FY20.
	The Fiscal Agent provided an update on both the State Office of AIDS' Ending the Epidemic Grant, as well as, HRSA's Ending the Epidemic Grant. The Fiscal agent is in the process of submitting requests to fill vacant positions and proceeding with the build-out of the exam rooms. The State has notified the County that the State will be purchasing the mobile van for the County's Wellness without Walls component.

Ms. Rovito agreed that it is the most logical next step in attempt to obtain input from the target population.
