Strategies for Older People Living with HIV/AIDS

Clinical treatment strategies for managing older HIV patients have been released in a new report, *The HIV and Aging Consensus Project: Recommended Treatment Strategies for Clinicians Managing Older Patients with HIV.* The treatment strategies were developed by the American Academy of HIV Medicine (AAHIVM), the American Geriatrics Society (AGS), and the AIDS Community Research Initiative of America (ACRIA).

The report is part of the organizations' HIV and Aging Consensus Project, developed to assess how the presence of both HIV and common age-associated diseases alter the optimal treatment of HIV as well as other co-morbidities. The purpose of the report, developed by a panel of experts with experience both in the fields of HIV and Geriatrics, is to provide best practice guidance for HIV practitioners and other health care providers who treat, diagnose, and refer older patients with HIV disease.

Governor Brown signed six bills that are HIV-related. All are effective Jan 1, 2012. For the full text of each bill, click on the name of the bill and author.

HIV Prevention:

- SB 41 (Yee) allows nonprescription sale of syringes (NPSS) by pharmacies in California. The bill eliminates the need for local government and pharmacies to opt into a program in order to sell syringes over the counter, and eliminates the need for county health departments to manage a program. It also raises the number of syringes that an individual may purchase and possess to 30, and allows syringe possession statewide when syringes have been obtained from a physician, pharmacist or authorized syringe exchange program. The provisions of the bill sunset on January 1, 2015.
- AB 604 (Skinner) permits the California Department of Public Health to authorize syringe exchange programs in locations where the conditions exist for the rapid spread of viral hepatitis, HIV or other potentially deadly diseases. A signing message can be found here.
- AB 1382 (Hernandez) allows HIV test counselors who are currently authorized to perform HIV tests waived under the Clinical Laboratory Improvement Act (CLIA) to also perform two additional Food and Drug Administration-approved tests: one for hepatitis C virus (HCV), and another which combines tests for both HIV and HCV. This legislation will enable HIV counseling and testing sites to use the new oral rapid HCV and combination HIV/HCV tests when they become available in 2012.
- SB 422 (Wright) permits physicians to notify local health department Partner Services (PS) staff of an HIV-positive patient and with the patient's written consent provides patient contact information for follow up. This law also allows PS staff to make partner notifications to persons believed to be a spouse, sexual or needle sharing partner without disclosing any identifying information about the HIV-positive person or the physician.

HIV Surveillance:

- Revised. SB 946 (Steinberg and Evans) beginning July Effective January 1, 2012, OA can make changes to the HIV/AIDS case report form without amending the California Code of Regulations. This law will enable OA to more readily comply with Centers for Disease Control and Prevention HIV/AIDS reporting guidance and facilitate efficient and accurate HIV/AIDS case reporting.
- AB1088 (Eng) requires Office of AIDS to add major Asian and Pacific Islander categories to HIV/AIDS reporting data, HIV care data and HIV prevention data reports.

COUNSELING AND TESTING

The following report, HIV Counseling and Testing at CDC-Funded Sites, United States, Puerto Rico and the US Virgin Islands, 2006-2007, provides a summary of HIV counseling and testing (CT) data and is intended to be used by HIV program managers and policy makers, HIV CT service providers, evaluators, researchers, and others at the local, state, and national levels who are interested in the public health implications of HIV prevention program data.
