Sacramento Region: Let's Talk Meth

Let's Talk Meth – yes, we're talking about methamphetamine. The power of methamphetamine does not discriminate and lurks among all communities; however, when HIV and methamphetamine intersects, challenges arise, negatively impacting the treatment and care of people living with HIV/AIDS. Earlier studies in the 2000s (Semple et al., 2002; Potula & Persidsky, 2008) have shown a correlation between methamphetamine use and increased HIV risk; this trend remains consistent as we embark 2021 (Volkow, 2020). At the local level, the Sacramento County Methamphetamine Coalition, in partnership with the Sacramento County Division of Behavioral Health Services, Substance Use Prevention and Treatment Services, recently launched the "Let's Talk Meth" (https://letstalkmeth.org/about/) digital outreach campaign to increase community awareness, education, promote partnership and knowledge of the local substance abuse resources available to individuals in need of support and treatment (Sacramento County, 2020). To further highlight the impact of HIV and methamphetamine in the Sacramento region, the Central Valley and Northern Interior AIDS Education and Training Center will showcase an online four -part recorded training series in early December on the intersectionality of HIV, methamphetamine, and mental health. What should you do if you get a call claiming there's a problem with your Social Security number or account?

If there is a problem, Social Security will mail you a letter with your Social Security number. Generally, Social Security will only contact you if you have requested a call or have ongoing business with them. The latest scam trick of using robocalls or live callers has increased. Fraudsters pretend to be government employees and claim there is identity theft or another problem with one's Social Security number, account, or benefits.

Scammers may threaten arrest or other legal action, or may offer to increase benefits, protect assets, or resolve identity theft. They often demand payment via retail gift cards, wire transfers, pre-paid debit cards, internet currency, or mailing cash.

Social Security employees will never threaten you for information or promise a benefit in exchange for personal information or money. Social Security may call you in some situations, **but will never**:

- Threaten you.
- Suspend your Social Security number.
- Demand immediate payment from you.
- Require payment by cash, gift card, pre-paid debit card, internet currency, or wire transfer.
- Ask for gift card numbers over the phone or to wire or mail cash.

Don't be fooled! You should look out for:

- A caller saying there is a problem with your Social Security number or account.
- Any call asking you to pay a fine or debt with retail gift cards, wire transfers, pre-paid debit cards, internet currency, or by mailing cash.
- Scammers pretending they're from Social Security or another government agency. Caller ID or documents sent by email may look official but they are not.

How to protect yourself and your family!

If you receive a questionable call, hang up, and report the call to the Office of the Inspector General at 800-447-8477.

- Don't return unknown calls.
- Ask someone you trust for advice before making any large purchase or financial decision.
- Don't be embarrassed to report if you shared personal financial information or suffered a financial loss.
